WHEREAS, the Poet Laureate serves as an ambassador for poetry and the literary arts in Cortland County and participates in civic events, public readings, and educational and cultural activities throughout the County; AND

WHEREAS, the Poet Laureate Selection Committee has completed its review process and has recommended the appointment of Phillip Asaph as the Cortland County Poet Laureate; NOW THEREFORE BE IT

RESOLVED, that Phillip Asaph is hereby appointed as the Cortland County Poet Laureate for a term commencing immediately and expiring December 31, 2027, in accordance with the provisions established by Resolution No. 73-25 and Resolution No. 11-26 of the Cortland County Legislature, said appointment serving at the pleasure of the Cortland County Legislature and subject to the Cortland County Code of Ethics; AND BE IT FURTHER

RESOLUTION NO. 35-26

Establishing and Delegating Authority to the County Administrator to Execute Certain Agreements in Accordance with Established County Procedures - County Legislature

WHEREAS, Resolution No. 126-22 of the Cortland County Legislature authorized the County Administrator to execute contracts that had been previously approved through the adopted County budget, thereby reducing duplicative legislative authorizations and improving administrative efficiency; AND

WHEREAS, the County Legislature retains authority over appropriations, budget adoption, and the establishment of purchasing policies and thresholds, while day-to-day administrative execution of minor contractual matters is appropriately delegated to the County Administrator; AND

WHEREAS, the County's adopted procurement policy establishes a discretionary purchasing threshold of \$2,500, under which formal quoting is not required; AND

WHEREAS, requiring individual legislative approval for contracts at or below the discretionary procurement threshold creates unnecessary administrative delay and consumes legislative and staff time disproportionate to the fiscal impact of such agreements; AND

WHEREAS, authorizing the County Administrator to execute contracts within this existing discretionary threshold, when sufficient budgeted appropriations exist, will improve operational efficiency, reduce administrative burden, and maintain appropriate fiscal controls; AND

WHEREAS, such authority would apply only to contracts that comply with all applicable procurement laws, County purchasing policies, and budgetary controls, and would not diminish the Legislature's fiscal oversight role; NOW THEREFORE BE IT

RESOLVED, that the Cortland County Legislature hereby authorizes the County Administrator to execute contracts and agreements on behalf of Cortland County in an amount not to exceed \$2,500 per contract, consistent with the County's discretionary procurement threshold, provided that:

- Sufficient funds have been appropriated in the adopted County budget; and
- The contract complies with all applicable provisions of New York State General Municipal Law, County procurement policies, and any other applicable laws or regulations; and
- The contract is for routine operational purposes and does not involve the acquisition or disposition of

real property, long-term obligations, or matters otherwise requiring legislative approval by law;
; AND BE IT FURTHER

RESOLVED, that this authorization is intended to further the policy established by Resolution No. 126-22 by eliminating unnecessary duplicative legislative approvals for minor contracts, while preserving legislative oversight through the budget process and established procurement thresholds; AND BE IT FURTHER

RESOLVED, that the County Administrator shall file quarterly with the Clerk of the Legislature a report identifying all contracts executed pursuant to this authorization, including the vendor name, contract purpose, and dollar amount of each contract.

RESOLUTION NO.

Establishing a Standardized Policy Development Framework for County Operations

WHEREAS, the Cortland County Legislature is the policy-making body of the County and is responsible for establishing overall legislative direction; AND

WHEREAS, the County Administrator is responsible for the day-to-day administration of County operations and utilizes policies and procedures as administrative tools to implement legislative direction and ensure consistent, effective, and transparent County operations; AND

WHEREAS, Cortland County currently lacks a uniform, countywide framework for the development, review, and implementation of operational policies and procedures, resulting in inconsistent practices across departments; AND

WHEREAS, Departments have historically relied on legacy practices or informal guidance without a standardized process for review, coordination, documentation, or revision; AND

WHEREAS, establishing a standardized policy development framework will promote consistency, accountability, transparency, and continuity across county government while preserving legislative authority; AND

WHEREAS, it is the intent of the Legislature to organize the process by which policies and procedures are developed and administered, without limiting its authority to adopt, amend, or rescind policy by resolution; NOW THEREFORE BE IT

RESOLVED, that the Cortland County Legislature hereby adopts the following policy development framework for countywide operational policies and procedures:

Section 1. Establishment of Framework

The Cortland County Legislature hereby establishes a standardized framework for the development, review, and

administration of policies and procedures.

Section 2. Legislative Authority

The Legislature retains full authority to:

- Adopt policy direction by resolution;
- Direct the County Administrator to develop policies and procedures; and
- Review, amend, or rescind any administrative or operational policy or procedure developed pursuant to this framework.

Nothing in this resolution shall be construed to limit or diminish the authority of the Legislature.

Section 3. Role of the County Administrator

The County Administrator is hereby authorized and directed to:

- Develop and draft policies and procedures consistent with legislative intent;
- Consult with Department Heads, or other resources, as appropriate;
- Submit proposed policies and procedures to the relevant statutory committee for review;
- Implement approved policies and procedures following committee review; and
- Maintain a centralized repository of all adopted policies and procedures and revisions thereto.

Section 4. Role of Legislative Committees

Statutory committees shall provide subject-matter oversight and review of policies and procedures within their respective jurisdictions.

Each policy or procedure shall identify a responsible department for implementation. The statutory committee with jurisdiction over that department shall review the policy or procedure. Any question regarding committee jurisdiction shall be resolved by the Chair of the Legislature.

Committee review shall include consideration of:

- Alignment with legislative intent;
- Clarity, effectiveness, and potential impacts; and
- Readiness for implementation.

Section 5. Role of Department Heads

Department Heads may establish department-level procedures tailored to their operational needs, provided such procedures do not conflict with adopted countywide policies.

Department-level procedures:

- Shall be submitted to the County Administrator for review to ensure consistency, unless otherwise exempt;
- Must comply with applicable countywide policies;
- Must be maintained in writing; and
- Must be periodically reviewed and updated.

Section 6. Policy Structure and Content Principles

Policies and procedures developed under this framework shall follow a generally uniform structure sufficient to promote consistency, clarity, and effective implementation.

As appropriate to their subject matter, such policies and procedures shall address:

- Purpose and intent;
- Scope of applicability;
- Relevant legal or regulatory authority;
- Roles and responsibilities for implementation; and
- Any procedures or guidance necessary to support consistent administration.

The specific format, level of detail, and supporting documentation for policies and procedures shall be determined by the County Administrator, in consultation with affected Departments, and may evolve over time to reflect operational needs and best practices. All approved policies must be indexed and titled according to said format determined by the County Administrator.

All approved policies must reference the date approved and legislative committee that approved said Policy.

Authorize Supplemental Agreement No. 2 with Barton & Loguidice, D.P.C. for East River Crossing Over Tioughnioga River Bridge (BIN 3312310) Replacement - Department of Public Works

WHEREAS, the Cortland County Legislature authorized an agreement with the New York State Department of Transportation for the East River Crossing Bridge (BIN 3312310) Replacement, PIN 375687, through Resolution No. 44-24; AND

WHEREAS, the East River Crossing Bridge Replacement Project is eligible for funding under Title 23 U.S. Code, as amended which calls for the apportionment of the costs of such program to be borne at the

ratio of 80% Federal Funds, 20% non-federal funds; AND

WHEREAS, the said projects costs may also be eligible for reimbursement of 15% of the project costs through NYSDOT AID (Marchiselli Aid) provided the funds are appropriated by the State of New York; AND

WHEREAS, the Department of Public Works solicited and received proposals from firms interested in providing design services for said project; AND

WHEREAS, the Public Works Committee appointed a Selection Committee to review said proposals, and make a recommendation to the Public Works Committee of a firm that would best provide Professional Engineering Services; AND

WHEREAS, the Public Works Committee recommended that Barton and Loguidice Engineers, D.P.C. of 443 Electronics Parkway Liverpool, NY 13088 provide Professional Engineering Services to the Cortland County Public Works; AND

WHEREAS, the Cortland County Legislature approved said agreement with Barton and Loguidice, D.P.C through Resolution No. 244-20; AND

WHEREAS, the Cortland County Legislature approved an agreement with the New York State Department of Transportation (NYSDOT) for the Acquisition of Right of Way (ROW) property through Resolution No. 57-21; AND

WHEREAS, during the course of the Design Phase of said project, it was determined that the Bridge carrying East River Crossing was eligible for the National Register of Historic Places, which requires the preparation of a finding document, an alternative analysis and a memorandum of agreement to meet section 106 a 4 (f) requirements; AND

WHEREAS, during the preliminary design phase it was also determined that the right of way phase of the project would be completed by the consultant instead of the NYSDOT because of possible schedule concerns; AND

WHEREAS, the additional scope of work for the design phase of the said project needs to be changed to include the ROW incidentals and acquisition; AND

WHEREAS, contingent upon funding by the NYSDOT, the Cortland County Public Works Committee wishes to further said project, by authorizing Supplemental Agreement # 2 with Barton and Loguidice, D.P.C. which adds \$252,000.00 to the Construction Agreement; NOW THEREFORE BE IT

RESOLVED, that the County Administrator, upon review and approval by the County Attorney, or designee, is hereby authorized to execute Supplemental Agreement No. 2 with Barton and Loguidice, D.P.C, for the continued Construction, Construction Inspection, and Construction Services of the East River Crossing Bridge Replacement; AND BE IT FURTHER

Authorize Agreement with Axon Justice Premier Plus - Public Defender

WHEREAS, the County was awarded and has already received block grant funds from the Division of Criminal Justice Services for the State's Aid to Defense for Discovery Reform Program in the amount of \$129,309.00 and supplemental block grant funds in the amount of \$127,983.00, for a total of \$257,292.00; AND

WHEREAS, the Grant Award Notice specifically states: "This funding must be used to support public defense services and expenses related to discovery reform implementation, including, but not limited to, digital evidence transmission technology, administrative support, computers, hardware and operating software, data connectivity, development of training materials, staff training..."; AND

WHEREAS, AXON is a company that provides digital evidence management and storage; AND

WHEREAS, the Cortland County District Attorney's office, the New York State Police, the Cortland City Police Department, and the SUNY Cortland University Police Department currently use Axon for video/digital evidence gathering; AND

WHEREAS, AXON has agreed to provide such services to the Cortland County Public Defender's Office at a cost of \$72,229.60 for five years, January 1, 2026 – December 31, 2030; NOW THEREFORE BE IT

A Resolution Urging the New York State Legislature and Governor Kathy Hochul to Enact the Packaging Reduction and Recycling Infrastructure Act (S.1464/A31749)

WHEREAS, in New York State, more than 18 million tons of municipal solid waste (MSW) is generated each year, or about five pounds per day and two-thousand pounds per year for every person who lives in the state; AND

WHEREAS, greenhouse gas (GHG) emissions from the waste sector represent about 12 percent of statewide emissions; AND

WHEREAS, the most significant GHG emissions impact during the lifecycle of products and packaging result not from disposal but from the production of products and packaging that eventually become waste; AND

WHEREAS, in addition to the climate impacts of waste, the costs associated with its recycling and disposal impose a significant burden on Cortland County taxpayers; AND

WHEREAS, the Cortland County Strategic Development Plan, adopted by the Cortland County Legislature in December 2024, identifies Sustainability as its third primary focus area and states that Cortland County will “preserve its natural resources for future generations;” AND

WHEREAS, the Climate Action Council’s Final Scoping Plan recommends New York State enact legislation to create a product stewardship framework or target products with the greatest GHG impact, such as packaging, printed paper, carpets, tires, textiles, solar panels, wind turbines, batteries, appliances, and

mattresses; AND

WHEREAS, S.1464/A.1749 would enact the Packaging Reduction and Recycling Infrastructure Act to create an Extended Producer Responsibility (EPR) program for packaging materials; AND

WHEREAS, S.1464/ A.1749 would make producers legally and financially responsible for mitigating the environmental impacts of their packaging; AND

WHEREAS, Cortland County faces an imminent waste management crisis, with the county landfill set to reach capacity within the next 10 years; AND

WHEREAS, the Cortland County Legislature previously adopted Resolution No. 54-25, titled ‘A Resolution Urging the Enactment of the Packaging Reduction and Recycling Infrastructure Act (S.1464/A.1749),’ in March 2025; AND

WHEREAS, the Packaging Reduction and Recycling Infrastructure Act would not only provide meaningful relief to Cortland County taxpayers and all local government budgets in Central New York with total savings of up to \$46 million dollars, according to an economic analysis from Beyond Plastics, but also reduce GHG emissions from the production and disposal of consumer goods by incentivizing producers to reduce waste and design products that are more sustainable; AND

WHEREAS, S.1464/A.1749 would also prohibit certain toxic and dangerous chemicals in packaging, including per- and polyfluoroalkyl substances (PFAS), orthophthalates, bisphenols, halogenated flame retardants, heavy metals such as lead, and other chemicals posing a threat to human health and safety and the environment; AND

WHEREAS, the New York State Senate previously passed the Packaging Reduction and Recycling Infrastructure Act 2025 as S.4246-B/A.5322-B during the 2025 Legislative Session; AND

WHEREAS, the New York State Assembly did not bring up S.4246-B/A.5322-B for debate at the end of the 2025 Legislative Session; NOW THEREFORE BE IT

RESOLVED, the Cortland County Legislature calls on both houses of the New York State Legislature to pass and Governor Kathy Hochul to sign S.1464/A.1749 during the 2026 Legislative Session; AND BE IT FURTHER

RESOLVED, the Cortland County Legislature calls on Governor Hochul and the New York State Legislature to also enact an Extended Producer Responsibility (EPR) program for paper products, which is currently excluded from this legislation, in recognition of their significant contribution to GHG emissions and municipal recycling costs; AND BE IT FURTHER

WHEREAS, the gross deduction for County purposes will be provided for quarterly; AND

WHEREAS, the 2025 fourth quarter sales tax information has been provided by the New York State Comptroller's Office showing a total collection for fourth quarter 2025 to be \$10,512,527.57; AND

WHEREAS, the total amount available for distribution is \$10,137,527.57, after the direct deduction for County purposes; AND

WHEREAS, Cortland County receives (55%), or \$5,575,640.16 of the total net quarterly distribution; AND
