Amend 2021 Budget to Accept New York State Septic System Replacement Grant and Authorize Contract with New York State Environmental Facilities Corporation and New York State Department of Environmental Conservation - Health Department, Environmental Health Division

WHEREAS, the New York State Department of Environmental Conservation (DEC) and the New York State Environmental Facilities Corporation (EFC) provides grant funding to replace cesspools and septic systems to reduce the environmental and public-health impacts associated with the discharge from cesspools and septic systems, AND

WHEREAS, the DEC/EFC has notified Cortland County that it is eligible for up to \$85,000 in grant funding to incentivize the replacement of a cesspool with a septic system, install, replace or upgrade septic systems or septic system components, or install enhanced treatment technologies, including an advanced nitrogen removal system located near priority water bodies, AND

WHEREAS, there is no local match associated with this program, AND

WHEREAS, the County Administrator and Public Health Director both recommend acceptance of this funding and authorize signature of the program contract agreements, NOW THEREFORE BE IT

RESOLVED, the Cortland County Legislature hereby accepts the New York State Septic System Replacement Grant and amends the 2021 budget accordingly, AND BE IT FURTHER

Amend 2021 Budget to Accept New York State Department of Health State Rural Transit Assistance Funding - Planning Department

WHEREAS, for more than 20 years the New York State Department of Health provided funds to the Department of Social Services to provide the essential service of providing for and arranging for non-emergency Medicaid transportation service for medical appointments, AND

WHEREAS, the Department of Social Services contracted with First Transit, Inc. for said transportation service which included a State approved method of paying a share of costs for operating public transportation to benefit all Medicaid recipients using the system to get to medical appointments, AND

WHEREAS, in 2010, the State Department of Health was given statutory authority under 365-h of Social Services Law to assume the administrative management of non-emergency transportation from counties and has since mandated that a private Medicaid brokerage system be implemented, which began in Cortland County October 1, 2013, AND

WHEREAS, as a result of the transfer of the administrative management of non-emergency transportation to a private Medicaid brokerage system, First Transit lost 40% of its revenue to operate the public transportation service in Cortland County, AND

WHEREAS, transportation providers throughout New York State lobbied to their State Representatives to provide funding to make up for the loss of funding due to the transfer of the administrative management of non-emergency transportation to a private Medicaid brokerage system, AND

WHEREAS, Governor Andrew Cuomo, the New York State Department of Health (NYSDOH) and the New York State Department of Transportation (NYSDOT) have identified a series of action targets to preserve critical access to necessary Non-Emergency Medical Transportation (NEMT) services through a coordinated public transportation system in upstate New York, AND

WHEREAS, one of these action targets is to provide rescue funding to the public transportation service in Cortland County to address the lost revenue as a result of the transfer of the administrative management of non-emergency transportation to a private Medicaid brokerage system, AND

WHEREAS, on May 3, 2021, a letter was sent from the New York State Department of Health by the Office of Health Insurance Programs notifying Cortland County of an electronic payment in the amount of \$368,241 for a State Medicaid payment intended for Rural Transit Assistance purposes enacted as part of the State Fiscal Year 2020-2021 Enacted Budget, AND

WHEREAS, Cortland County has received a Rural Transit Assistance payment in the amount of \$368,241 which will be paid to Cortland County's public transportation provider, First Transit, Inc., NOW THEREFORE BE IT

RESOLVED, the Cortland County Legislature authorizes the County Treasurer's office to release said payment to First Transit and to create the following 2021 budget modification:

WHEREAS, there is grant funding available through the New York State Office of Community Renewal through its Community Development Block Grant Program (CDBG) 2020 CARES Act, AND

WHEREAS, in order to be eligible for these funds municipalities must propose activities that meet national objectives and be related to preparing, preventing, and/or responding to the COVID-19 global pandemic as outlined in the grant program guidance, AND

WHEREAS, all program funds must be expended within 12 months of award, AND

WHEREAS, given the technical nature of this grant application it is recommended to retain the assistance of a professional grant writing services to complete and submit this application by the August 27, 2021 deadline,

WHEREAS, Thoma Development Consultants of 34 Tompkins Street Cortland NY 13045 have submitted a proposal for grant writing services for this application in an amount not to exceed \$4500, NOW THEREFORE BE IT

Local Law "C" of 2021, a Local Law Authorizing 12 and 13 Year Old Licensed Hunters to Hunt Deer with a Firearm or Crossbow During Hunting Season with the Supervision of an Adult Licensed Hunter

BE IT ENACTED by the Cortland County Legislature as follows:

Section 1. Legislative Intent

The intent of this Local Law is to authorize Cortland County to permit 12 and 13 year old individuals to participate in the new and safe hunting opportunities in accordance with Environment Conservation Law § 11-0935. The enacted 2021-2022 New York State Budget, include a pilot program, allowing the opportunity for young hunters, ages 12 and 13, to hunt deer with firearms and crossbow through 2023 if a county authorizes such action within their municipality. Cortland County is passing this local law as hunting is a valued tradition for many families, and this new opportunity allows experienced, adult hunters to introduce the value of hunting to the next generation. Furthermore, teaching young people safe, responsible, and ethical hunting practices will ensure a rewarding experience for the youth, while providing quality food to families and contributing to important deer management population control practices.

Section 2. Pilot Program Authorization

Pursuant to Environmental Conservation Law, ECL 11-0935, Cortland County elects to participate in the temporary program to allow for young hunters, ages twelve (12) and thirteen (13), to hunt deer with a firearm, to include rifles, shotguns, and muzzle loaded firearms or crossbow through 2023.

Section 3. State Requirements to Adhere Once Authorized

Twelve (12) and thirteen (13) year old licensed hunters shall be allowed to hunt deer with the following requirements to be followed:

- Twelve (12) and thirteen (13) year old licensed hunters shall be under the supervision of a licensed adult hunter, age 21 years or older, with a rifle, shotgun, or muzzle loading firearm in areas where and during the hunting season in which such firearms may be used; and
- Twelve (12) and thirteen (13) year old licensed hunters shall be allowed to hunt deer under the supervision of a licensed adult hunter, age 21 years or older, with a crossbow during the times when other hunters may use crossbows; and
- Supervision of a licensed adult hunter, age twenty-one (21) years or older, with at least three (3) years of experience who exercises dominion and control over the youth hunter at all times is required; and

- All licensed twelve (12) and thirteen (13) year old hunters as well as their adult supervisors shall be required to wear fluorescent orange or pink clothing while engaged in hunting to an extent and covering so designated pursuant to the law, rules, and regulations promulgated by the State of New York; and
- All licensed twelve (12) and thirteen (13) year old hunters shall remain at ground level while hunting deer with a crossbow, rifle, shotgun, or muzzleloader; and
- Notwithstanding any State or Federal Law to the contrary, this local law shall not authorize the hunting of bear by twelve (12) and thirteen (13) year old with a firearm or crossbow.

Section 4. Local Law Filing Requirements

A copy of this local law shall be sent to the New York State Department of Conservation as well as the NYS Department of State

Section 5. Severability

If any clause, sentence, paragraph, subdivision, section or part of this law, or the application thereof to any person, individual, corporation, firm, partnership, entity or circumstance shall be adjudged by any court of competent jurisdiction to be invalid or unconstitutional, such order or judgment shall not affect, impair, effect or invalidate the remainder thereof, but shall be confined in its operation to the clause, sentence, paragraph, subdivision, section or part of this law or in its application to the person, individual, corporation, firm, partnership, entity or circumstance directly involved in the controversy in which such order or judgment shall be rendered.

Section 5. Effective Date

This local law shall take effect immediately upon filing and publication in accordance with Section 27 of the Municipal Home Rule.

Adopt Cortland County Coordinated Public Transit Human Services Transportation Plan 2020 - Cortland County Planning Department

WHEREAS, the New York State Department of Transportation/Federal Transit Authority requires that an updated Transportation Needs Assessment be completed by Cortland County to address federal mobility management goals that were first established under the Safe, Accountable, Flexible, Efficient Transportation Equity Act (SAFETEA-LU) and continued under the Moving Ahead for Progress in the 21st Century Act (MAP-21) which was passed in 2012, and were reaffirmed through the FAST Act (Fixing America's Surface Transportation Act) signed into law December 2015, AND

WHEREAS, Resolution No. 263-13 authorized the adoption of a Cortland County Coordinated Public Transit Human Services Transportation Plan 2013 which addressed the federal mobility management goals first established under the SAFETA-LU and continued under the MAP-21 which passed in 2012, AND

WHEREAS, Cortland County is currently utilizing the Federal Transportation Administration programs Section 5311 Formula Grant for Rural Areas, Section 5310 Enhanced Mobility for Seniors and Individuals with Disabilities, and the Coronavirus Aid, Relief and Economic Security (CARES) Act to improve public transportation services available to residents of Cortland County, AND

WHEREAS, the Cortland County Coordinated Public Transit Human Services Transportation Plan 2020 was prepared to address federal mobility management goals first established under the SAFETA-LU, MAP-21, and the FAST Act, AND

WHEREAS, the adoption of the Cortland County Coordinated Public Transit Human Services Transportation Plan 2020 will update the coordinated plan currently in effect to better address the transportation needs of Cortland County by encouraging coordination efforts between providers of transportation and cooperation between human service agencies which could increase efficiencies in operation and provide more transportation options; marketing current and proposed services to the general public and educating the public and those who work with specialized populations on the available transportation services; working with other counties in the region to create a transportation network not constrained by county borders; and using available FTA funding to work on coordination efforts and the creation of new services to address unmet transportation needs, NOW THEREFORE BE IT

AGRICULTURE AND PRIVATE LAND CONSERVATION

Agricultural Environmental Management (AEM) Planning – We have three new program participants, one Tier 2 update request, and two grazing and one barnyard 3a plans are still underway. Three 3b CNMPs are in progress with one nearing completion.

BMP Implementation – One stream corridor restoration project with buffer, fencing and alternative water supply is underway. A grazing system design was completed and is ready for procurement. We still have a barnyard design underway. One waste management system started last summer is fully complete and another waste management system project is waiting for the contractor to start.

Other Ag BMPs/Grants – The Climate Resilient Farming grant plans of work were submitted. AGNP reports are being completed. We have two projects that may be canceling due to change in landowner priorities. A request was submitted for cover crop funding for 2021. USC BMP verification is underway.

COMMUNITY NATURAL RESOURCES MANAGEMENT AND PLANNING

Town of Cortlandville Aquifer Protection – We continue to support the Town's efforts to prevent mining into the aquifer. NYSDEC has announced their intention to rescind the negative declaration. The applicant is allowed a chance to respond to the notice by May 14, 2021. DEC's letter further states that public comments made the Department aware that the data and analysis used to generate the 2002 report cited may still exist, and that if these data can be provided to the Applicant in a timely manner, Applicant should evaluate the data as part of its assessment of whether the proposed mining pond has the potential to impact the quantity and quality of municipal water.

If the Department decides to rescind the negative declaration following receipt of Applicant's response or time period to respond, the application would become incomplete until such time as the Department receives a DEIS and accepts the statement as adequate for public review. The Department's rescission of the negative declaration would be followed by its issuance of a positive declaration (requiring preparation of a DEIS) and public scoping of the required contents of the DEIS.

SWCD responded and provide information for a FOIL request from the mine operator's attorney. Further data referenced above was also provided at the Department and Town's request.

Stormwater – The 2020 Stormwater Maintenance Program and Report for Cortlandville is complete.

Culvert Rehabilitation – The Heath Rd culvert replacement and stream corridor stabilization project is underway. Six other projects are at various stages of design – two are complete, fully permitted, and ready for construction.

Smith Corona TCE Remediation – Consultants are running a test of shutting down the air stripper. We have been reviewing water level and water quality data.

Invasive Species Management – Several virtual presentations to community groups and clubs have been made this past month. The FL-PRISM grant is complete and closed. We submitted the final report and completed our presentation. We are continuing work under the second NYSDEC Aquatic Invasive Species spread prevention grant which included the boat cleaning unit at Dwyer Park. We have hired boat stewards to continue outreach/education efforts this year and they will be deployed to the various launches starting Memorial Day weekend. We are working with Skaneateles Lake and Song Lake associations on ways to manage and monitor their newly identified invasives, and have developed volunteer monitoring protocols for invasives in Little York.

PROGRAMS AND EDUCATION

Conservation Services - Our Spring Planting Program distribution was April 22nd at the county fairgrounds. We distributed about 40,000 tree and shrub seedlings to over 400 landowners. The Pond Stocking program is underway. Information and the fish fingerling order form are posted on our website.

Spring Education Programs – The Regional **Envirothon** was held May 4th with three Cortland County teams participating in the virtual event. We are awaiting results. The State Envirothon will be May 25-28th.

Soil and Water Stewardship Week was celebrated April 25 – May 2, 2021 with the theme “Healthy Forests, Healthy Communities”, and during that week Cortland County Soil and Water Conservation District celebrated its **75th anniversary** on May 1st. We hope you enjoy your complimentary tree seedling. Check out our Facebooks posts!

Drinking Water Week, May 2-8, 2021, continues the celebration of District accomplishments. While the Water Festival normally held the first Saturday in June has been cancelled again this year, some virtual Water Festival activities including water related videos, as well as the coloring contest and other traditional activities will still be offered. Information will be on our website.

Please join us at Dwyer Park on May 18th at 1PM to recognize and celebrate the Conservation District, its Board, and staff for 75 years of service to Cortland County. We will have a brief tour of some recent activities of the District at the county park, and discuss some future projects.

Public Transit

Cortland Transit continues to contend with a driver shortage and ridership levels that have not returned to pre-pandemic levels, however ridership is trending upwards which Cortland Transit officials attribute to more people being out and about post vaccination.

Routes remain fare-free.

Zachariah Newswanger, Associate Vice President, Facilities Management at SUNY Cortland has let us know there is still interest in developing a public transit route to serve SUNY Cortland students and staff (on and off campus). This discussion was put on hold due to the pandemic. The MMC is facilitating discussions between Cortland County, Cortland Transit and SUNY Cortland to explore this idea further.

Volunteer Driver Program

CAPCO has agreed to take the lead on the proposed Volunteer Driver Program, modeled after the St. Lawrence County-based-Volunteer Transportation Center's VDP. The new program would be an expansion of their current volunteer driver program with greater community agency participation. The St. Lawrence County-based-Volunteer Transportation Center will help CAPCO get the program up and running. The next meeting with the VTC is in early May at CAPCO. Please let me know if you would like to participate in this planning.
