A Home Rule Request for Special Legislation to Amend the Tax Law, in Relation to Extending the Authorization for Imposition of Local Mortgage Recording Tax in Cortland County - County Clerk

WHEREAS, the Cortland County Legislature adopted Resolution No. 76-23, “A Home Rule Request For Special Legislation to Amend the Tax Law, in Relation to Extending the Authorization For Imposition of Mortgage Recording Tax in Cortland County”; AND

WHEREAS, the request for special legislation was approved and the Cortland County Legislature adopted Local Law No. 9 of 2023 - a Local Law Amending Local Law 1 of 2007, as Last Amended by Local Law 3 of 2021, Extending the Imposition of a Mortgage Recording Tax in Cortland County; AND

WHEREAS, New York State Tax Law §253-v presently authorizes Cortland County to adopt and amend local laws imposing a mortgage recording tax of twenty five cents (\$.25) for each one hundred dollars (\$100.00) and each remaining major fraction thereof of principal debt or obligation which is or under any contingency may be secured at the date of execution thereof, or at any time thereafter, by a mortgage on real property situated in Cortland County and recorded on or after the date upon which such tax takes effect, (beginning September 30, 2007 and ending December 1, 2025); AND

WHEREAS, in the current economic climate it would create a fiscal hardship for Cortland County that receives this revenue if this source of revenue were to expire, and such a loss would result in a substantial burden on County property owners through increased property taxes or loss of essential services; NOW THEREFORE BE IT

RESOLVED, that this Legislature endorses and requests that the necessary information and forms be forwarded to the County Legislature in order that an appropriate Home Rule Request can be acted upon by this body; AND BE IT FURTHER

RESOLVED, that the Clerk of the Legislature is hereby directed to provide certified copies of this Resolution to New York State Senator Lea Webb and New York State Assembly member Anna Kelles in order to request the introduction of Home Rule Legislation regarding this matter.

December 2024 Activities

- Meetings: NYS Office of Court Administration, LEPC, IT Steering Committee and DMV Software Demonstration
- Report as required by NYS Office of Court Administration has been submitted to NYS by Jack Hess. At the time of this report, we are still awaiting a response. This report must be approved by NYS OCA before they will allow our software system to communicate with the NYS system. Temporary access accounts continue to be utilized to process work, at this time.
- Follow-up with New York State in regards to collecting Additional Mortgage Tax effective January 1, 2025. Discussed with Cortland County Attorney's office and collection will begin as scheduled.
- IT continues to work with our software vendor through some transitions with VPN connections, which are significant to the day to day operations of the Clerk's Office. This has allowed for our vendor to prepare for various updates in our system that are necessary for the collection of the Additional Mortgage Tax and changes with Pistol Permits, among other important tasks.
- Visited the Lewis County Clerk's Office to view the software they utilize. They utilize the same vendor as Cortland, but the platform is cloud based. A lot of time was spent reviewing the pros and cons, and how based on their experience they will remain with the Cloud when their contract is renewed. Cortland's current contract expires in 2027, but various options are being reviewed for the best interest of the office.

Activities Completed:

1. **Meeting Preparation & Follow Up:** Prepared all legislative meeting agendas, with the approval of the Committee Chairs and Chairman. Preparation of all committee minutes for approval. 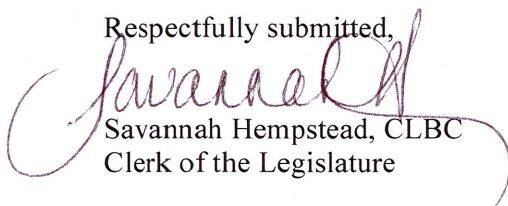

 - Microenterprise Grant:
 1. Submitted extension of current MAP agreement. All of the County materials are sufficient; they are waiting for a couple more items from Thoma.
 2. Most awardees have submitted for the second reimbursement.
 3. Completed the consultant monitoring.
 - Courthouse Grant:
 1. Received initial funding letter from the Speaker of the House. Corrections are needed to the letter. Currently working with Luke Davis from Anna Kelles' office to get the necessary corrections completed.
8. Miscellaneous:
 - Claimed the Little York Pavilion for Cortland County on Google.
